The following resolution was offered by Commissioner HOPPE and supported by Commissioner JONES.

WHEREAS, Section 21 of the Planning Enabling Act requires a planning commission to hold no less than four (4) regular meetings per year. MCL 125.3821(1); and

WHEREAS, a resolution must specify the time and place of the required regular meetings. *Id.*; and

WHEREAS, to comply with the Planning Enabling Act, the Eagle Township Planning Commission is scheduling regular planning commission meetings to be on the first Thursday of every month (12 meetings annually) at 7:00 p.m., resulting in more than four (4) regular meetings per year.

NOW THEREFORE BE IT RESOLVED:

1. The Eagle Township Planning Commission will hold regular meetings at the Eagle Township Hall located at 14318 Michigan Street, Eagle, MI 48822 at 7:00 p.m. on the first Thursday of every month (12 meetings annually) and the Township may post an annual meeting schedule at the Township Hall indicating specific meeting dates in a form similar to **Exhibit A**. Should the need arise, the Planning Commission may in accordance with applicable law reschedule regular meetings or adopt an amended annual meeting schedule to avoid placing meetings on days such as holidays.
