The meeting was called to order at 7:30 p.m. by Supervisor Morris with Pledge to the Flag. Board Members present: Supervisor David Morris, Deputy Clerk Jane Korroch, Treasurer Patti J. Schafer, Trustees Stephen Colby and Patricia Hazen. Absent: Clerk Wendy K. Simmons. Also present: County Commissioner Sara Clark Pierson, Deputy Mark Vermillion from Clinton County Sheriff Department, Fire Chief Casey Godlewski and Jeremy Nagel from Community Newspapers; also approximately 20 Township residents. Also State Rep. Larry Julian.

1. PUBLIC COMMENT - Chad Pitsch spoke about the traffic speed at the corner of Eaton Highway and Jones Road/Benton Road and presented a Petition requesting that stop signs be placed making it a four way stop. Reduced speed limits was also discussed but four way stop would be more effective. This would have to be worked out with the Eaton County Road Commission and Oneida Township. Chief Godlewski also suggested that a street light be placed on M-100 at State Road as this is a hard corner to see when you come upon it.

Gary Peterson stated that in regard to the mobile home park, we are virtually dead in the water and asked if the Township would be willing to invest in legal fees to see if the Consent Judgement could be set aside and that the Township should distance itself from the County and do its out planning and zoning. There was more discussion of the repercussions of the mobile home park being built including water problems, environment, traffic, property value to name a few. Mr. Morris has spoken with Mr. Fahey, the County's attorney and Richard Robinson who is the attorney for Dewitt. He would charge \$160.00 per hour to investigate court records and give an opinion as to whether or not we would have a case. The previous court case was discussed. Also discussed was whether or not Consumers could run natural gas to the area when the electrical is Tri-County Electric. Mr. Morris stated that in certain areas this can be intermingled. Rev. Burkhart stated that he had been told that the pipeline through the village would not be large enought to supply actually sued the County the mobile home park. Sara Pierson stated that before they were turned down by Planning and Zoning. Sara also tries to explain the client/attorney privilege being waived if residents were included in litigation negotiations.

Moved by Colby, supported by Schafer that Mr. Morris contact Mr. Robinson and ask him to go through court documents and Planning and Zoning records and give us an opinion as to whether or not we would have a chance of setting aside the Consent Judgment to try to stop the building of the mobile home park. The time alotted would be approximately 20 hours. Motion carried 4 yes, 1 absent.

Moved by Colby, supported by Schafer that Mr. Morris contact the Clinton County Road Commission to start the process of getting the corner of Eaton Highway and Jones Road/Benton Road to become a four way stop. Motion carried 4 yes, 1 absent.

Moved by Hazen, supported by Schafer that Mr. Morris contact Consumers Energy regarding the rate and installation costs for a light at M-100 and State Road and if consistent with the cost of the light near the elevator to request that a light be placed at State Road. Motion carried 4 yes, 1 absent.

- MINUTES moved by Schafer, supported by Colby to approve the minutes as printed. Motion carried 4 yes, 1 absent.
- TREASURER'S REPORT Moved by Colby, supported by Hazen to accept the report as printed. Motion carried 4 yes, 1 absent.
- 4. LETTERS were presented. No action required. Comment was made regarding the recycling grant and that Ron Hodge might be interested in doing a tire recycling again this year.
- 5. BILLS were reviewed. Moved by Hazen, supported by Schafer to pay same and any other regular bills received during the month. Motion carried 4 yes, 1 absent.
- MAINTENANCE PERSON Pat Hazen stated that Barb Dunn may be interested.
 Pat will speak with her.
- 7. FIRE CONTRACT Watertown and Oneida has notified the City that they will not renew the current fire contract when it expires. Moved by Schafer, supported by Colby that the City be notified that Eagle Township will not renew the existing contract. Motion carried, 4 yes, 1 absent.
- 8. FIRE CHIEF SELECTION moved by Colby, supported by Schafer that we would be agreeable to by-pass the fire contract for the selection of a new fire chief and we had previously sent a letter supporting Casey Godlewski. Motion carried 4 yes, 1 absent.

Chief Godlewski would like a fire board meeting on December 27. This date is alright with the Eagle Board. He will contact the others.

- 13. PORTLAND LIBRARY David presented a letter from Janice Mosser requesting that she speak to the Board. The clerk will contact her and request that she attend our February meeting.
- 14. BOARD OF REVIEW David appoints the following to the Board of Review: Leo Murphy, Harley Barnes and Jim Harsant. Moved by Schafer, supported by Colby to accept these appointments. Motion carried.

OTHER COMMENTS: Also discussed: David reports that the road abandonment on Herbison at Bauer has been recorded by the CCRC. Dan Schroeder asked how many people voted at the election. CCRC budget and appointment of new Road Commissioner.
