Public Hearing Eagle Township Board March 23, 2002

 Call to Order - The public hearing of the Eagle Township Board was called to order at 9:00 a.m. by Supervisor Morris at the Eagle Township Hall, 14318 Michigan Street, Eagle, MI.

Members present were: Supervisor David Morris, Clerk Wendy Simmons, Treasurer Patti Schafer, Trustee Stephen Colby, Trustee Patricia Hazen, and Deputy Clerk Georgia Cooper. Also present were: Representative Scott Hummel, Commissioner Sara Clark Pierson, Casey Race of Community Newspapers as well as approximately 10 township residents and interested persons.

- 2. Pledge of Allegiance Supervisor Morris lead in the Pledge of Allegiance.
- 3. Representative Scott Hummel Representative Hummel reported that both the House and Senate have passed the summer tax collection bill. He noted that thru amendments a \$2.50 per parcel payment would be made to Townships that have not previously collected the tax. The payment will be on going but must be appropriated each year. The agricultural and senior citizen deferments will still be available.
- 4. Alan Cropsey Mr. Cropsey, who is running for State Senate greeted the Board and audience.
- 5. Thanks Supervisor Morris recognized the efforts of Commissioner Clark Pierson on behalf of the residents of Eagle Township
- 6. Public Hearing, Annual Special Assessment District Supervisor Morris reviewed PA33, which allows the Township to levy up to 10 mills for Emergency Services. Until last year the Board has only asked for one mill. Last year the Board requested 1 ½ mills. Supervisor Morris also offered an update on the current status of fire service.

Mrs. Dee Schraggle Schraegle spoke up with concerns regarding the current fire service situation.

Mr. Ron Hodge spoke regarding the extra ½ mill, he felt that the public was in favor of it last year to stay with Grand Ledge service, and that the Board is taking for granted that the public would want the extra ½ mill again. Mr. Hodge clarified that his concerns relate to the unknown factors relating to costs.

Commissioner Clark Pierson spoke out in favor of looking at the long-term benefits of the Board's action to create the LGRFA. As a political figure, she hears positive comments for this action.

Mr. Ernie Sakraska had a question regarding the station location.

Mr. Mark Therrian asked how much the land would cost Eagle Township as Watertown Township already owns the proposed land.

7. Close of Hearing, Annual Special Assessment District - Mr. Morris closed the public hearing.

- 5. Budget Review and Approval of Salary Portion Treasurer Schafer reviewed the proposed budget and salary adjustments for the Board. Mrs. Georgia Cooper made a motion to approve the salary portion of the 2002 2003 budget. Mr. Babbit supported the motion. Aye: All, Nay: None: Motion carried.
- **6. Proposed work for 2002/2003** Supervisor Morris reported that the Monroe Road Bridge is being constructed now and may be open by July 4th. Clark Road will be black topped this summer. He also reported that it is not anticipated that a lot of gravel work to be done this year. And, the Board has budgeted for two applications of chloride.
- 7. Budget Approval Resolution Treasurer Schafer made a motion to approve the 2002 2003 budget as presented. Trustee Colby supported the motion. Ayes: Schafer, Simmons, Hazen, Colby, Morris; Nays: None; Resolution carried.
- 8. Emergency Services Millage Clerk Simmons made a motion to levy 1 ½ mill for EMS. Trustee Hazen supported the motion. Ayes: Hazen, Simmons, Schafer, Colby, Morris; Nays: None; Resolution carried.
- Operating Millage Resolution Treasurer Schafer made a motion to assess 1% allocation as allocated. Trustee Hazen supported the motion. Ayes: Colby, Schafer, Hazen, Simmons, Morris; Nays: None; Motion carried.
- 10. Other Mr. Murphy stated that he would like the Board to pursue having the Clinton County Road Commission black top the last mile of Howe Road from Grange Road west to the county line.
- 11. Adjournment Mr. Murphy moved to adjourn the meeting at 11:30 a.m. Trustee Hazen supported the motion. Aye: 5; Nay: 0; Motion carried.
