Exemptions per Township Ordinance Section 2-2015: Fire and/or medical services provided outside of Eagle Township under a mutual aid contract or agreement: fires caused by railroad trains which are the specific statutory responsibility of railroad companies and false alarms, except as otherwise provided.

**CODE ENFORCEMENT FEES**

**Penalties.** Any violation of the Zoning Ordinance shall constitute municipal civil infraction (as defined by Michigan Statute). The penalty for a municipal civil infraction shall be a civil fine determined in accordance with the following schedule:

	<b>Minimum Fine</b>	<b>Maximum Fine</b>
<b>1st Offense</b>	\$75.00	\$500.00
<b>2nd Offense</b>	150.00	500.00
<b>3rd Offense</b>	325.00	500.00
<b>4th Offense</b>	500.00	500.00

In addition, the violator shall pay costs which may include all expenses, direct and indirect, which Eagle Township has incurred in connection with the municipal civil infraction. In no case, however, shall costs of less than \$25.00 be ordered.

**FOUNDATIONS**

50¢ per square inch – Calculated on the base size of the monument plus 2 inch margins
